# Clinical & Interpretive

## **Clinical Information**

The immunoglobulin molecules (antibodies) function as surface receptors for antigens for B lymphocytes and as secretory products of plasma cells forming the humoral arm of the immune system. IgD represents one of the immunoglobulin heavy chain types. Immunoreactivity is a specific marker for B lymphocytes and plasma cells; it is

expressed normally on mantle zone lymphocytes. Diagnostically, staining for immunoglobulin heavy chains can aid in the diagnosis and classification of small B cell malignant lymphomas and multiple myeloma.

### Interpretation

This test does not include pathologist interpretation, only technical performance of the stain. If interpretation is required, order PATHC / Pathology Consultation for a full diagnostic evaluation or second opinion of the case.

The positive and negative controls are verified as showing appropriate immunoreactivity. If a control tissue is not included on the slide, a scanned image of the relevant quality control tissue is available upon request; call 855-516-8404.

Interpretation of this test should be performed in the context of the patient's clinical history and other diagnostic tests by a qualified pathologist.

### Cautions

Age of a cut paraffin section can affect immunoreactivity. Stability thresholds vary widely among published literature and are antigen dependent. Best practice is for paraffin sections to be cut within 6 weeks.

The charge of glass slides can be affected by environmental factors and subsequently may alter slide staining. Sending unsuitable glass slides can result in inconsistent staining due to poor slide surface chemistry.

Best practices for storage of positively charged slides: -Minimize time slides are stored after being unpackaged -Limit exposure to high humidity and heat -Minimize exposure to plastics
